#### Voting Member Dues

Dues are based on the annual gross sales of each member company for the previous fiscal year. Dues are billed annually for the year starting July 1. New member dues will be prorated after July 1.

- Sales under \$250,000** ..... \$230
- \$250,000 - \$750,000** ..... \$460
- \$750,000 - \$3,000,000** ..... \$690
- \$3,000,000 - \$6,000,000** ..... \$1150
- Over \$6,000,000** ..... \$1725

**Distributor** - a company which buys and sells model hobby merchandise, carries adequate inventory to immediately fill orders, calls on the retail trade, or distributes merchandise obtained from many sources. To qualify as a distributor a company must have been established for at least one year prior to applying for membership.

**Manufacturers Representative** - a company whose business is but need not be limited to, representing and selling products of model hobby manufacturers.

**Retailer/Mail Order/Internet** - a company whose principle business is the sale of merchandise at retail and sells such items as are known as model hobby products or supplies to the consumer.

**Affiliate** - any non-profit organization whose aims, goals, and product interests are compatible with those of the Association.

**Lifetime Members** - individuals, retired or who have left the industry, upon whom HMA has conferred lifetime membership a result of their contributions to the industry.
